

# What is a Youth Rehabilitation Order (YRO)?

It's a sentence for young people that could last anywhere between 1 and 3 years. During that time, you will have to complete certain requirements and keep appointments with the Youth Offending Service and, if needed, other agencies. The requirements and interventions will help you to avoid further offending.

#### **Possible requirements**

- Activity specified
- > Attendance Centre
- > Curfew
- > Drug testing
- > Drug Treatment
- > Education
- > Exclusion Zones
- > Intensive supervision and Surveillance
- > Intoxicating Substance treatment
- > Local Authority Residence
- > Emotional health Treatment
- Programme specified
- > Prohibited Activity specified
- > Supervision
- > Unpaid work

#### What are the rules?

- Tell your YOS Officer if you change address
- Keep each appointment, arrive on time, be polite, and free from alcohol or drugs. If you can't keep an appointment, telephone your YOS Officer beforehand to explain why and rearrange. You will need to provide something like a hospital appointment card or note from your employer.
- Attend Case Review and Planning Meetings.
- If you move but fail to inform us and we can't contact you, you will be arrested and brought to Court.
- If you don't keep an appointment without a good reason, we will give you a maximum of two written warnings. If you miss a further appointment without a good reason, we will then start breach proceedings.

#### Your Plan

Your plan may include;

- 1:1 meetings
- Group work
- Involvement with the victim/s
- Working in the community
- Referrals to health providers
- Support around education, training and employment

# Victims

The victim of your offence (if there is one) will be contacted by the YOS Restorative Justice Coordinator.

The victim may be invited to provide their input in the panel meeting. You will be given the opportunity to repair the harm you have caused to victim in some form.

In our experience, involving the victim provides a positive way forward for both you and the victim.

# Information for Parent(s)/Carer(s)

A parent/carer's contribution to the plan will be helpful in tailoring it to your child's needs. You will be asked to support and encourage your child to comply with the order. If you have any issues or concerns, please initially speak to your child's YOS worker.

#### Remember

The YOS works with young people based on their own needs and situations. So, you may have more appointments and spend more time with your YOS Officer, or other professionals, than someone who has committed the same office as you. Even if you committed the offence with someone else, you may get different amounts of time with the YOS and different activities or restrictions from them.
