

The only exception is adding an inscription to an existing memorial on the grave, and ONLY if the work is to be carried out on site. Contact the Cemetery Office overleaf for more details.

The Green Disposal Certificate MUST accompany the deceased on the day of the funeral and handed into the Cemetery Office prior to the burial. Should the Funeral Director decide to post the Green Disposal Certificate, it is then the Funeral Directors responsibility to ensure that the Cemetery Office has received the Certificate before the Interment takes place. Please Note: No Interments can proceed without this Certificate.
