# My Say Matters Youth and Democracy Annual Report April 2025 – March 2025

# 1. Introduction

'My Say Matters', Barnet's Child Participation and Family Involvement Strategy has been in place since May 2022. The strategy is underpinned by the concepts in the Lundy model of participation – Space, Voice, Audience and Influence. This report updates on activity between April 2024 and March 2025. My Say Matters and the concepts of co-production and youth participation remain securely embedded, still enjoying impressive support across the council and partner agencies. We continue to see a diverse range of young people taking part, who represent the wider community of Barnet, including those from minoritised communities, disabled children and those with SEN needs. Young people in Barnet want and expect to be listened to and the Council continues to respond to this demand and act on what they say.

A separate report is available on the work of BOP (Barnet on Point) our child in care council.

# 2. Youth and Democracy

Barnet's Youth and Democracy offer covers 3 areas supported by Rebecca Morris, Participation Officer:

- The UK National Youth Parliament and Barnet Youth Ambassador schemes 4 elected roles.
- Youth Assembly which sits up to 6 x per year in the Council Chamber young people propose, debate and vote on motions in front of elected members and senior council leaders.
- Youth Board council officers bring policies and projects to young people to get their input and to shape service delivery. This forum is monthly.

Our My Say Matters membership increased exponentially in the summer of 2024, likely due to the support of the Barnet Head Teachers network and other promotional activities

– we have seen 136 new members register since June 2024 and 113 young people, from 38 schools attended at least one youth and democracy event over the year. Our numbers peaked in October 2024 with 52 members attending Youth Assembly and 48 at the December session. Many of our Youth Assembly members attend Youth Board which has seen a peak of 26 attendees in February 2025. This compares very well to our active membership from 2023-24.

# 2.1 Barnet Youth Parliament and Youth Ambassador Scheme 2024-26 Cycle

Members of Youth Parliament are 11–18-year-olds elected to represent young people across the borough for a two-year term, and work on the issues of greatest concern to their constituents. MYPs take part in a national scheme supported by the National Youth Agency which includes an annual debate in the House of Commons chamber where two priorities are selected for the following year. There are over 300 sitting MYPs nationally.

Barnet's Youth Ambassadors work to identify the needs of local young people and support the work of Barnet's Youth Board where council officers and partners attend to consult young people and gain their views and involvement in policy making. All four elected young people attend Barnet's Childrens Partnership Board (BCPB) to represent the young people of Barnet.

Our Members of Youth Parliament (and pictured below) are:

- Connor Gill, age 17, Finchley Catholic High School (campaigning on improving mental health support)
- Freddie Atkinson, age 17, Saracens High School (campaigning on diversifying the curriculum)

### Barnet's Youth Ambassadors are:

- Eleanor Sidnick, age 14, JCoSS (campaigning on reducing school stress)
- Sylvia Bega, age 14, East Barnet School (campaigning on preventing knife crime)

All four young people are actively working on their campaigns and have received support from and had the opportunity to meet with related professionals. Whilst campaigning has to take part alongside educational and other commitments, each young person has been able to share their views and contribute to policy making in relation to their chosen topic as well as taking part in the broader My Say Matter offer. Connor has been a youth advisor to the NSPCC and is interested in developing a podcast to support the destigmatisation of talking about mental health and to sign post resources – discussions have started with our BICS service about this. Freddie has met head teachers and senior education leaders to share his proposals for creating safe spaces for difficult conversations in schools. Eleanor is in discussion with her own school regarding various elements of school support including toilet passes and Sylvia has met staff with our Vulnerable Adolescents service to share her ideas about supporting victims of knife crime.

# 2.2 Barnet Youth Assembly

Barnet Youth Assembly is a forum designed to encourage the participation of young people in the democratic process and to give them direct access to elected members and policy makers. It takes place in the chamber at Hendon Town Hall and is well supported by our councillors who take part in pre meeting networking with young people and listen to debates. Our Director of Children's Services and Chief Executive of BELS (Barnet Education and Learning Service) have also been regular attenders. Youth Assembly, which restarted in January 2023 remains an established part of the democratic calendar. The youth Co Chairs, elected by fellow Youth Assembly members are Purvi Shah, Rebecca Surcel and Vanshi Pujara. Rebecca meets with our Youth Chairs regularly to plan work and support their development in the role as they have full chairing responsibility during the Assembly sessions – this they do to a very high standard.

# 2.3 Barnet Youth Assembly Demographics

We are proud that our offer is accessible to and of interest to children from all walks of life. Our members appear to reflect the demographics of the borough in terms of gender, race, culture, religion and class. Although providing this data is not a condition of membership we know that young people attend from both the independent and state education sector. Our members have told us they have heritage from many parts of the globe: West, East and North Africa, the Caribbean, Central, East and Southeast Asia as well as European roots. We take an inclusive approach that means disabled and neurodiverse young people are supported to take part. Only 11 of our members have shared that they have a disability including vision and hearing loss, autism and Aspergers but we believe this to be an underestimate and will continue to encourage members to feel comfortable to share their additional needs. Whilst we do not ask our members about their personal background, we know from the information they chose to share with us that some have had adverse childhood experiences. We are pleased that our work offers a safe space for them to share these with peers and professionals who can affect the changes young people seek. We have slightly more female members. Young people are invited to share their preferred pronouns if they wish to.

# 2.4 Barnet Youth Assembly Activity

This is what our members tell us about attending Youth Assembly:

Young people are offered the chance to work with our Participation Officer to progress their motion if it passes. This year we have extended this to give all our members the chance to join a working group to realise the motion. This has enabled a wider range of children to learn more about the behind the scenes work of the council and meet officers and senior leaders in an informal way. They have learnt about policy making, the challenges of public sector delivery and gained confidence in navigating a professional environment.

Whilst it isn't always in the gift of the council to deliver the motion in full we are able to ensure our members have the chance to lobby for their ideas and contribute to change, whilst building skills for future life.






# 2.5 Links to Barnet Education and Learning Service

BELS Chief Executive Neil Marlow has been a champion for My Say Matters and regularly attends Youth Assembly and takes part in the debates and follow up. He has invited young people to be participants in Barnet's Schools and Settings Standards Partnership Board Meeting (SSSPBM) with headteachers and senior education staff and this has proved an effective way to progress motions that require the support of schools.

Winter's motion from 2023 regarding school councils has been discussed SSSPB meetings and as a result guidance written by him has been agreed by headteachers and circulated to all schools. It has also been agreed that Learning Network Inspectors will add an inquiry about school councils to their regular contact with schools, the result being a broader conversation about the ways in which pupil's voices can be heard. A recent survey to schools has explored this issue further. This is an excellent example of young people being part of all 4 quadrants of the Lundy participation model; Space, Voice, Audience and Influence.





Freddie also attended SSSPB in April 2025, to discuss his campaign around diversifying the curriculum. This led to a fruitful conversation about the complexities of discussing sensitive topics for example global conflicts in safe spaces which also support open exchanges of views between students. There are plans for Freddie to have further meetings with head teachers and Barnets PSHE lead.

### 2.6 Barnet Youth Board

Youth Board offers a monthly forum where council officers bring policies and strategies at the early stages so that young people can be involved in co-production from the outset. It takes place in a mix of on-line and face to face sessions and is a sought-after slot for seeking feedback. Staff from across the council and partner agencies attend and there is strong evidence of the influence of young people on policy making as shown in Table 4 and Fig 1 below which illustrate that all council directorates have had contact with Youth Board.

Demographics of Youth Board members reflect the analysis in 2.3 above as there is considerable overlap in membership.



# 3. Other My Say Matter Activity

# 3.1 Barnet Youth Question Time

On 3 February, more than 30 young people aged 11-18 took part in the first ever Barnet Youth Question Time. The online session gave young people the chance to put their questions to the Council Leader, Cllr Barry Rawlings, and his Cabinet. For an hour the council's political leaders were grilled on a variety of issues affecting young people, from council finances and tackling the cost-of-living crisis, through to sustainability and dealing with the vape epidemic. Questions were submitted in advance with follow-up questions taken on the night and the discussion was lively, with the informed audience pressing the Cabinet on a number of tough subjects. Thanks go to the evening's excellent Youth Chairs – Dia and Zoi, both 13, and Winter, 16, all students at The Compton School, who planned the event alongside our Barnet Communications Team, asked the questions and encouraged the audience to ask their own and to get involved in other ways to make their voices heard in local decisions that affect them.

# 3.2 Barnet Mayor's Projects

Barnet Mayors continue to support My Say Matters vigorously and champion the voice of young people by offering a slot at the start of full council meetings. In October 2024 Onyinyechi, Isabel, Mimi, Tochi from Woodhouse College spoke about the importance of Black history under the theme Reclaiming Narratives, including celebrating the contributions of Black Barnet residents to the local education sector and economy.

In January 2025 Saba, Shaimaa, Alina and Alexa (all students at Copthall School) addressed full council on the topic of Barnet's 60<sup>th</sup> anniversary. Their speeches recognised all the elements that make Barnet a great place to grow up and their hopes for the Barnet of the future.

Young people greatly value this slot which brings them into the heart of local democracy giving them a chance to speak whilst also seeing the behind-the-scenes preparation for full council and meeting officers and council members on the night.

# 3.3 Interviewing the New Director of Children's Services

In May 2025 six My Say Matters members took part in interviewing for the new Director of Children's Services as part of the Youth Stakeholder Panel, which was also chaired by a young person - Zakia. This was an excellent opportunity for our members to gain access to the inner workings of a senior recruitment process and take decisions about how to conduct their interview, including writing their own questions and undertaking a scoring exercise. Their feedback contributed to the appointment of the final candidate who was also the Youth Panel's first choice. All our young people showed exceptional maturity and gave relevant and perceptive feedback.

Connor, our Member of Youth Parliament said:

# 4. Conclusion and Forward Plan

My Say Matters remains an embedded way of working and has been further extended in 2024-25, with greater numbers taking part and the delivery of more complex and challenging projects. Our approach has visibility within the partnership and across the council via strong networks of support, with all directorates using the My Say Matters approach in some form. There is a thriving culture of coproduction and participation and strong evidence of impact which is actively fed back to our members.

It remains the case that My Say Matters sells itself to professionals who need little encouragement to have a go. The expectation from elected members of resident involvement supports this approach and the council is a place where officers are consistently linking to residents and services users in meaningful relationships to drive change and improvements. This continues to be business as usual with an increase in fun and creative approaches to the work that consistently engage young people.

### **Future Plans**

- 1. Youth Assembly will be undertaking two trips to the Houses of Parliament in May and June 2025 (37 slots in total) including the chance to observe a sitting and meet MPs.
- 2. Preparation is about to start for the 2026-28 UK Youth Parliament and Barnet Youth Ambassador election cycle.
- 3. We will continue to target our offer to make it inclusive, and work alongside schools to increase our membership.
- 4. We will encourage teams or service areas who have not been part of My Say Matters to utilize the approach, being directed by our members to areas of their interest. For example young people have indicated they would like to know more about how their voices are included in regeneration plans.

# Appendix 2 Red Quadrant Findings – Interviews with Youth Board Feb 2025

### 11.2 Barnet Youth Board

Working Together 2023 requires scrutiny to 'Ensure that the voice of children and families is considered as part of scrutiny and that this is at the heart of arrangements through direct feedback, informing policy and practice.'

There was a meeting set up for the scrutineer to meet with a group of twenty young people from the Barnet Youth Board, with a wide age range. We would like to thank all the young

people who took part for giving up their time to contribute to this process. It was explored with the young people what they understood about keeping children and young people (C&YP) safe in Barnet; what the safeguarding issues were for them and what they would change to make C&YP safer in Barnet.

Some of the areas covered by the C&YP were issues about online abuse, particularly how children were targeted by bullies through this medium. Other areas covered were stop and search by police and there was a health discussion about whether parents should be informed of this or not. The discussion ranged from it was the private business of the young person, to parents knowing and understanding the circumstances so they could keep their child safe.

Interestingly vaping was a major issue covered by most of the groups, including pressure to vape as part of bullying. I understand this topic has been covered by the group to feedback to councillors within Barnet council.

Another topic covered by one group was about being able to have 'courageous' conversations in school – this was particularly sensitive around the war in Gaza. This group of (older) young women felt that it was 'shut down' in schools if this topic was raised. One young woman felt it would be better to be able to have a wider discussion.

When asked what they would change or improve, all suggested that better information in schools about who to go to for bullying support, including advice about how to handle difficult circumstances and deescalate situations, as well as handling cyber bullying. There was a general view that schools in Barnet did a good job keeping children safe when they were in school, it was the online environment where safeguarding was an issue for young people in this group.
